# Kinetics and Mechanism of Addition of Benzylamines to Methyl $\alpha$-Cyanocinnamates in Acetonitrile

Studies of substituent effects on the reactions of amine nucleophiles with olefins which are activated by electronacceptors. $Z$ and $Z$ ' in eq $I$. have shown important difference

in the mechanism between the reactions in aqueous solution and in acetonitrile. In aqueous solution. the reactions were found to proceed through a zwitterionic intermediate. $\mathrm{T}^{ \pm}$. with imbalanced transition states (TSs) in which the development of resonance into the $Z Z^{\prime}$ group lags behind charge transfer or bond formation. ${ }^{1}$ The lag in resonance development has been expressed by a larger $\alpha_{\text {nuc, }}$, obtained by varying substituent Y (eq 1). than $\beta_{\text {nuc. }}$ a Brönsted type coefficient based on variation of amine nucleophile. ${ }^{1}$ The imbalance, $\mathrm{I}_{\mathrm{tu}}=a_{n 11.4}-\beta_{\mathrm{nu}, \mathrm{c}}$, was

found to increase with increasing resonance stabilization of the carbanionic product. 2 , in aqueous solution, e.g.. in the order $\mathrm{CN}, \mathrm{CN}<\mathrm{H}_{3} \mathrm{NO}_{2}{ }^{1}$.

In contrast, however the amine additions to olefins in acetonitrile were found to occur by a concerted formation of the $\mathrm{C}_{6}-\mathrm{N}$ and $\mathrm{C}_{\beta}-\mathrm{H}$ bonds in a single step process leading to a neutral product. 1. ${ }^{\text {. }}$ The rates of amine additions in acetonitrile are in general extremely slower than in aqueous solution ( $k_{\mathrm{a}}(\mathrm{aq}) \cong 10^{4} \cdot k_{\mathrm{a}}(\mathrm{MeCN})$ ), but the relative order remains the same. $k_{a}(\mathrm{CN}, \mathrm{CN}) \gg k_{a}\left(\mathrm{H}, \mathrm{NO}_{2}\right)^{1.2}$ An unexpected trend was observed in acetonitrile, however, that the $\alpha$-carbon becomes more positive $\left(\rho_{\mathrm{Y}}<0\right)$ in the TS than in the reactant for $\mathrm{Z} . \mathrm{Z}^{\prime}=$ $\mathrm{CN}, \mathrm{CN}$ (benzylidenemalononitrile. BMN$)^{\text {b }}$ in contrast to the negatively charged $\mathrm{C}_{4}\left(\rho_{Y}>0\right)$ for $Z, Z^{\prime}=\mathrm{H} . \mathrm{NO}_{2}(\beta$-nitrostyrene. NS ) ${ }^{2,}{ }^{2}$ The sign of $\rho_{\mathrm{Y}}$ is invariably positive in aqueous solution ${ }^{1}$ as expected from an imbalanced TS in which a
greater degree of negative charge builds up $C_{\alpha}$ than that expected from a delocalized TS.

In view of this interesting trend. we conducted a similar amine addition reaction with methyl $\alpha$-cyanocinnamate (MCC) in acetonitrile. eq 2 . The purpose of the present paper is

to further explore the different mechauism of the amine addition to olefin between the reactions in aqueous solution and in acetonitrile by examining the structure-reactivity behavior of olefins activated by cyano and keto groups. eq 2.

Another interest in this work is to examine the sign and magnitude of the cross-interaction constant ${ }^{2}, \rho_{\mathrm{XY}}$ in eqs 3

where X and Y are substituents in anine (BA) and in the substrate (MCC). respectively, in eq 2. The $\rho_{\mathrm{XY}}$ has been shown to have a negative sign in addition processes, e. g., bond formation in the $S_{\mathbf{~}} 2$ reactions and in the addition of anines to an olefin with $c a .-0.6 \sim-0.8 .^{3}$

## Results and Discussion

The reactions studied in this work (eq. 2) obeyed a simple mate law given by eqs 4 and 5 where $k_{2}$ is the rate constant for the benzylamine (BA) addition to the methyl $\alpha$-cyanocinnamates (MCC). No catalysis by a second BA molecule was detected

in the present studies. Plots of $k_{\mathrm{cbs}} \vee s[\mathrm{BA}]$ were linear for $c a$.

10 -fold increase in [BA]. The $k=$ values obtained from the slopes of these plots are summarized in Table 1. The selectivity parameters. the Hammett $\rho_{\mathrm{X}}$ and $\rho_{\mathrm{Y}}$ values and the Bronsted $\beta_{\mathrm{X}}$ values. are also shown in Table 1 together with the corss-interaction constant $\rho_{\mathrm{XY}}$ (eq. 3). Although the $\beta_{\mathrm{X}}$ values are based on the plots of $\log k=(\mathrm{MeCN})$ against $\mathrm{p}_{\mathrm{a}}$ of the conjugate acid BAs in water. they are thought to be reliable since it was found both experimentally and theoretically that the absolute values of $\mathrm{pK}_{3}$ for conjugate acids of amines in MeCN differ from those in water by a reasonably constant value of $\Delta \mathrm{p} K_{\mathrm{a}}\left(=^{1} \mathrm{p} \mathrm{K}_{\mathrm{Mec}} \mathrm{C}-\right.$ $\mathrm{pK}_{\mathrm{H}_{2}}$ ) $) \cong 7.5$. $^{+}$Bruice and coworker ${ }^{5}$ have investigated ester hydrolysis mechanism using $p$-nitrophenyl 2 -cyano-3-(p-methoxyphenyl) propenoate ( $p-\mathrm{CH}_{3} \mathrm{O}-\mathrm{C}_{6} \mathrm{H}_{4} \mathrm{CH}=\mathrm{C}(\mathrm{CN}) \mathrm{COOC}_{6} \mathrm{H}_{4}-$ $p-\mathrm{NO}_{2}$ ). They found that the ester hydrolysis occurs with the expulsion of $p-\mathrm{NO}_{2}$-phenoxide leaving group in aqueous solution. This step was found to have a substantially high
activation barrier. $\Delta H^{\mp}=26.9 \pm 1.0 \mathrm{kcal} \mathrm{mol}^{-1}$ with $\Delta S^{\dot{m}}=-6.0$ $\pm 3.1$ e.u. In the present work. such ester aminolysis mechanism may also be a possibility. but in our product analysis we found no ester aminolysis product. The leaving group in the present case is $\mathrm{MeO}^{-}$group which is a very poor nucleofuge and the reaction medium is also an aprotic one (MeCN) so that such possibility can be safely ruled out. ${ }^{6}$

In general. rates of amine additions to activated olefins are over $10^{2}$-fold faster in water than those for the corresponding reaction in acetonitrile. Although the rate-limiting steps in both media are believed to be the initial nucleophilic addition, $k_{\mathrm{a}}$ in water and in acetonitrile. effects of the activating (electron-withdrawing) groups ( $Z . Z^{\prime}$ ) on the rate are found to be different: In water the stabilization of the incipient $s p^{3}$ carbanionic center. 1. (delocalization of which into the activating groups ( $\mathrm{Z} . \mathrm{Z}^{\prime}$ ) lags behind the $\mathrm{C} \alpha-\mathrm{N}$ bond formation) is important

[^0]so that the rate (intrinsic rate) increases with the sum of electron accepting power of the activating groups. $\Sigma \sigma_{\mathrm{p}}{ }^{1}$. In acetonitrile. however the rate was found to increase with the sum of electron-accepting ability of $Z, Z^{\prime}$ through $\pi$-orbitals i.e., the sum of through conjugative electron-accepting power. $\Sigma \sigma_{\mathrm{p}}^{-}$. This is of course a manifestation of the mechanistic difference in the two media i.e. the amine addition reaction in water proceeds through an intermediate, whereas that in acetonitrile proceeds by a single step addition. The rates of amine additions to various activated olefins in water and in acetonitrile are compared in Table 2. The available rate data in aqueous solution show general parallelism between the intrinsic rate ( $\left.\log k_{0}\right)^{7}$ and the sum of the normal substituent constants ( $\Sigma \sigma_{\mathrm{p}}$ ). For MCC the data in aqueous solution are not available. but we can predict that the $\log k$ values will fall in between benzylidenemalononitrile (BMN) and benzylideneindanedione ( BD ). In acetonitrile. however. only the through conjugative electron shift, i.e.. the electron shiff through $\pi$-orbital. is important and $\beta$-nitrostyrene (NS) and $\beta$-nitrostilbene (NSB) have nearly the same rate constants since in the latter the benzene ring has negligible $\pi$-electron accepting effect due to non-coplanarity of the ring with the vinylic $\pi$-orbital. ${ }^{\text {dd }}$ Again the rate for $\beta$-cyano- $\beta$-4-nitrostilbene (CNS) is the lowest due to the non-coplanarity of the $p$-nitrobenzene ring. The rate for MCC is faster than CNS but is slower than NSB ( $\cong \mathrm{NS}$ ) , which indicates that the through conjugative electronwithdrawing power of the COOMe group ( $\sigma_{\mathrm{p}}^{-}=0.75$ ) is not fully operative.

The cross-interaction constants. $\rho_{\mathrm{XY}}$ in eqs. 3. are all negative for the six series in Table 2. This shows that the cross-interaction constants. $\rho_{\mathrm{XY}}$. in the bond formation process is negative. ${ }^{\text {c. } 3}$ The size of $\rho_{\mathrm{X}}$ for MCC has again an intermediate value, but is well within the range of the $\rho_{\mathrm{XY}}$ values found for $S_{X} 2$ processes ( $\rho_{\mathrm{XY}}=-0.6 \sim-0.8$ ) provided the fall-off factor of ca. $0.47^{8}$ for an intervening $\mathrm{CH}_{2}$ group in the benzylamine is accounted for $\rho_{\mathrm{XY}} \cong 0.42$. It is also notable that the magnitude of $\rho_{\mathrm{XY}}(-0.49)$ as well as $\rho_{\mathrm{Y}}(+0.91)$ value for MCC is larger than those for $\mathrm{BMN}\left(\rho_{\mathrm{YY}}=-0.31\right)^{\text {lc }}$ and $\mathrm{BID}\left(\rho_{\mathrm{XY}}=-0.33\right){ }^{\text {Id }}$ These are consistent with somewhat higher degree of $\mathrm{N}-\mathrm{C} \alpha$ bond formation in the TS than for the BA addition to other activated olefins listed in Table $2 .^{3}$

[^1]The kinetic isotope effects. $k_{\mathrm{H}} / k_{\mathrm{D}}$ (Table 3 ), involving deuterated benzylamine nucleophiles ${ }^{9}\left(\mathrm{XC}_{6} \mathrm{H}_{4} \mathrm{CH}_{2} \mathrm{ND}_{2}\right)$ are greater than one, $k_{\mathrm{H}} / k_{\mathrm{D}}=1.8 \sim 2$. I. suggesting a possibility of hydrogen-bond formation ( $\mathbf{3} \mathrm{and} /$ or 4 ) as have been proposed for the BA additions in acetonitrile to other activated olefins listed in Table 2. The hydrogen bonding of the $\mathrm{N}-\mathrm{H}$ proton toward one of the oxygen atoms in the COOMe group. 3. (mostly toward the ester oxygen. since the trans $\mathrm{C}=\mathrm{C} / \mathrm{C}=\mathrm{O}$ form is more stable) is also a possibility, albe it such hydrogenbonding may involve a too long H -bond as the lone pair on N (m:) of BA approaches to the $\mathrm{C} \alpha=\mathrm{C}_{\beta} \pi$-bond almost vertically from above (or below) the molecular plane of MCC.

The $k_{\mathrm{H}} / k_{\mathrm{D}}(>1.0)$ values increase with an electron acceptor Y and an electron donor X . which is in line with the $\mathrm{C}_{4}-\mathrm{N}$ bond formation in the TS with a greater degree of bond making by a stronger electron-donor $\mathrm{X} . \delta \sigma_{\mathrm{X}}<0$ (with a larger positive Y , $\dot{\partial} \rho_{\mathrm{Y}}>0$ ) and by a stronger electron-accepter $\mathrm{Y} . \dot{\delta} \sigma_{\mathrm{Y}}>0$ (with a larger negative $\mathrm{X} . \delta \rho_{\mathrm{X}}<0$ ) leading to a negative cross-interaction constant $\rho_{\mathrm{Kr}}$, eq. 3b.

The activation parameters, $\Delta H^{\dot{亡}}$ and $\Delta S^{\dot{\dot{\prime}}}$ (Table 4), are quite similar to those for the corresponding reaction of other activated olefins in Table 2 in acetonitrile with low $\Delta H^{\ddagger}$ and large negative $\Delta S^{\dot{\dot{m}}}$ values. These are consistent with the concurrent $\mathrm{N}-\mathrm{C}_{\alpha}$ and $\mathrm{H}-\mathrm{C}_{\beta}$ bond formation in the TS. 3. Since exclusion repulsion energy in the $\mathrm{N}-\mathrm{C}_{0}$ bond naking is partially offset by the bond energy of the partial bond formed. and also by the $\mathrm{H}-\mathrm{C}_{\beta}$ bond formation, barrier to bond formation in the rate determining step should be low with little variation depending on X and/or Y . This is because the higher barrier for a weaker nucleophile ( $\delta \sigma_{\mathrm{s}}>0$ ) is partially offset by a stronger acidity of the $\mathrm{N}-\mathrm{H}$ proton in the H -bond formation. The large negative entropy of activation is in line with four-centered constrained TS structure. 3.

In summary. the kinetics of the addition of X-substituted benzylamines(BA) to Y-substituted methyl a-cyanocinnamate(MCC) in acetonitrile at $25.0^{\circ} \mathrm{C}$ have been studied. The

reaction is studied under pseudo-first-order conditions by keeping a large excess of BA over MCC . respectively. The addition of $B A$ to MCC occurs in a single step in which the additon of $B A$ to $\mathrm{C}_{0}$ of MCC and proton transfer from BA to $\mathrm{C}_{\beta}$ of MCC take place concurrently with a four-membered cyclic transition state structure. The sign and magnitude of the crossinteraction constant. $\rho_{\mathrm{XY}}(=0.49)$, are comparable to those found in the normal bond fommation processes in the $\mathrm{S}_{\mathrm{N}} 2$ and addition reactions. The normal kinetic isotope effect $\left(k_{\mathrm{H}} / k_{\mathrm{D}}>\right.$ 1.0) and relatively low $\Delta H^{+}$and large negative $\Delta S^{+}$values are also consistent with the mechanism proposed.

## Experimental

Materials. Merk GR acetonitrile was used after three distillations. The benzylamine nucleophiles. Aldrich GR, were used after recrystallization. Methyl cyanoacetate and benzaldehydes were Aldrich reagent.

Preparations of methyl $\alpha$-cyanocinnamates. The methyl $\alpha$ cyanocinnamates were prepared by the literature method of Zabicky. ${ }^{16} \mathrm{~A} 0.1 \mathrm{M}$ ethanolic solution of both benzaldehyde and metlyl cyanoacetate with few drops of piperidine was refluxed for $4 \sim 6$ hours. The solvent was quickly evaporated, and the residue cooled. filtered off. and purified by repeated recrystallisations from ethanol (yield $>85 \%$ ). Melting point. IR (Nicolet 5 BX FT-IR) and ${ }^{1} \mathrm{H}$ and ${ }^{13} \mathrm{C}$ NMR (JEOL +00 MHz ) data were found to agree well with the literature values. ${ }^{10}$

Kinetic measurement. The reaction was followed spectrophotometrically by monitoring the decrease in the concentration of methyl- $\alpha$-cyanocinnamate. [MCC]. at $\lambda_{\text {max }}$ of the substrate to over $80 \%$ completion. The reaction was studied under pseudo-first-order condition, [MCC] $=8.0 \times 10^{-5} \mathrm{M}$ and $[\mathrm{BA}]=0.1 \sim 0.4 \mathrm{M}$ at $25.0 \pm 0.1^{\circ} \mathrm{C}$. The pseudo first-order rate constant. $k_{\text {obs. }}$ was determined form the slope of the plot ( $\mathrm{r}>0.994$ ) $\ln [\mathrm{MCC}](2.303 \log [\mathrm{MCC}])$ vs time. Secondorder rate constants. $k_{\mathrm{s}}$. were obtained from the slope of a plot ( $\mathrm{r}>0.993$ ) of $k_{\mathrm{ob}}$ vs. benzylamine with more than four concentrations of more than three nus and were reproducible to within $\pm 3 \%$.
Product analysis. The analysis of final products was difficult due to partial decomposition during product separation and
purification. We therefore analysed the reaction mixture by NMR (JEOL 400 MHz ) at appropriate intervals under exactly the same reaction conditions as the kinetic measurement in $\mathrm{CD}_{3} \mathrm{CN}$ at $25.0^{\circ} \mathrm{C}$. Initially we found a peak for CH in the reactant. $p-\mathrm{ClC}_{6} \mathrm{H}_{5} \mathrm{CH}=\mathrm{C}(\mathrm{CN}) \mathrm{COOMe}$ at 8.23 ppm . which was gradually reduced, and a new two peaks for $\mathrm{CH}-\mathrm{CH}$ in the product. $p-\mathrm{ClC}_{6} \mathrm{H}_{5}\left(\mathrm{MeOC} \mathrm{S}_{4} \mathrm{H}_{4} \mathrm{CH}_{2} \mathrm{NH}\right) \mathrm{CH}-\mathrm{CH}(\mathrm{CN}) \mathrm{COOMe}$. grew at 3.79 and 4.78 ppm as the reaction proceed. No other peaks or complications were found during the reaction except the 3 peak height changes indicating that the reaction proceeds with no other side reactions.
