Abstract

Now Korea is also out of the drug cleansing country. it is impossible to get rid of them with the national public power. It is time for a treatment plan for these. They need a certain period of time and regular periods of rest and control over sports. Our humanities are researching to understand the changing human images of today. In parallel, medical convergence will also have to be transformed in various ways for human healing. Recently, we can see the case of healing with the combination of oriental medicine, natural healing and western medicine. Furthermore, the structure of medical convergence for the fight against disease can be analyzed as an example. South Korea is also preparing for various convergence programs focusing on natural sciences such as engineering, medical care, and the environment. In order to prevent drug addiction it is important to determine the department responsible for handling the problem of substance abuse. we need to improve the environment that they can be combined with Ondol therapy and natural healing therapies. Furthermore, I expect that fusion medicine will contribute to improving the quality of life of drug addicts and become a successful model to revitalize local economies in particular.

1. Introduction

Cultural integration can also be called establishment as a result of cultural connection. It is to propagate several new cultural elements, encounter existing cultural elements and ultimately create a new culture that combines elements of two cultures. Culture reflects how a group of people live their lives. Values, religious practices, beliefs, art, customs, food, language and social interaction help to define a social group. Culture can evolve over time and is often impacted by aspects of other cultural groups.

It is not uncommon for cultures to become similar to one another or even combine and take on a new identity. This fusion is known as cultural convergence.[1] Medical convergence is a reflection of the new Western medicine element in traditional oriental medicine. For this reason, we contribute to medical and cultural diversity. As a result, all the identities of the two cultural elements remain. In this respect medical consolidation can be seen as demonstrating its strengths.

Especially in cases of internal disorders and diseases of the nervous system, it is said that treatment through

fusion of medicine can see good effect. These treatments can increase the trust between patients and medical staff. In addition, natural healing as an alternative medicine and nutritional food elements can ensure higher cure. In the diversity of cultural variation, the medical and cultural integration refers to a phenomenon in which a new medical culture emerges as a result of contact between a unique culture of a particular society and a foreign culture.

This is not a threat to the identity of the unique medical culture. As a result, it will be a fruit of its own efforts to strengthen itself in medical culture. In this regard, today's medical convergence is caused by the interaction between the medical revolution and new medical discovery and radio wave. When future scholar Alvin Toffler (1928.10.4.~2016.6.27.) visited Korea in September 2005, he said, "The breakthrough of the future economy must be found through convergence rather than a single business sector or a single technology. Korea's future depends on these "convergence technologies." the fusion of knowledge of culture, experience, content, community, and so on is a knowledge-based business model, he also emphasized convergence by concluding that "the fusion of knowledge model and that is the core of convergence marketing." The fruit of his research, "Future Shock"(1970), In the book, in which he synthesized disparate facts from every corner of the globe, he concluded that the convergence of science, capital and communications was producing such swift change that it was creating an entirely new kind of society.[2]

In this paper, I tried to pursue health and social welfare together through medical convergence based on the main subject of a culture of convergence. Recently, organized gangs in Taiwan and Japan have been caught up in buying and selling a large amount of methamphetamine with a market value of 30 billion won. It was revealed as transaction a large number of drugs when they met in the middle of Gangnam, Seoul. rather than in a suburban area.

Artists' drug accidents are never ending. Now Korea is also out of the drug cleansing country, and drug trafficking is more than 10,000 people, reaching about 14,000 people a year.[3] If more than 10,000 people are arrested in proportion to the population of 100,000, it is impossible to get rid of them with the national public power. In Korea, 14,214 people were arrested in 2016, exceeding two figures per 100,000 people. As a result, If the addicts in the North Korean methamphetamine were not rehabilitated, it would be impossible to eradicate drugs. It is time for a treatment plan for these. They need a certain period of time and regular periods of rest and control over sports.

Recently, we can see the case of healing with the combination of oriental medicine, natural healing and western medicine. Furthermore, the structure of medical convergence for the fight against disease can be analyzed as an example. "Today, traditional boundaries are disappearing in every field, it is impossible to describe a specific field without referring to other fields, and without a whole field, one field can not be fully explained."The "Big Idea" in *The Lexus and the Olive Tree* is found on page 232 where Friedman explains that: "if you can't see the world, and you can't see the interactions that are shaping the world, you surely cannot strategize about the world. "He states that "you need a strategy for how to choose prosperity for your country or company."[4]

2. Recently, drug trafficking among foreign violent organizations

2.1 Foreign violence group drug distribution case

October 19, 2017 4:00 pm Near the Yeoksam Station in Gangnam-gu, Seoul. he approached the Taiwanese by a Japanese immigrant from Japan, he pushed out a 1,000 won bill. Taiwanese people got into the car as they saw the serial number written on the bill. The banknote number was a promised password before meeting two

people. The narcotics transaction tangent was a method of moving to the place of transaction after confirming the sign with the serial number of the one thousand won banknote each other with the counterparty. It was known for bringing these methamphetamine for domestic and Japanese for the purpose of circulation.

The Investigators confiscated 8.6 kg of methamphetamine from them. It is an amount equivalent to market value of 28.8 billion won and can be dosed 290,000 at the same time (0.03 g for one dose, 100 thousand won for sleeves). Up until now narcotics trading was done mainly in the secret place at night. Drug trading in the middle of Seoul under sunlight is unusual. Prosecutors officials said, "People's traffic at these stations judged that many spaces were able to reduce suspicion, and they made a deal in the middle of Gangnam." They said that the reason for trading methamphetamine in Korea is "because the punishment level is much higher than that in Korea if they are captured after they have been traded in China or Japan".

In order to pass these domestic customs, after having made several stories, they hid a methamphetamine wrapped in aluminum foil. It was loaded on a cargo ship departing from Guangzhou in China, and brought it to Incheon Port passed through Hong Kong and Taiwan.[5]

Such cases are mostly cases where existing overseas violence organizations were caught in the process of smuggling or distributing methamphetamine to the country. As it is this time, it was analyzed a new type that was caught by trading overseas violent organizations. In order to prevent such drug trafficking incident from now on, it is necessary to strengthen such as upwardly amending the sentence. Moreover, we should expand cooperative investigations with foreign countries.

2.2 Entertainer drug addiction case

In the 1970s, the marijuana case began to spread among the US military, the beginning of the entertainer drug scandal dates back to 1975. At that time, Lee 00, Yoon 00 and others were arrested on suspicion of cannabis smoking. The top stars led the folk music which is prevailing at that time, such as Kim 00, Jung 00, Shin 00, Joe 00. they are enormously complex, the whole entertainment industry is complex. It led to the shaking wave. After that, again in 1987 led to the cannabis wave. Jeon 00, Lee 00, Kim 00 and others were detained by marijuana smoking suspect. Jeon 00 were punished on the same charges in 1997, 1999 and 2008. Lee 00 was caught in a total of three marijuana cases in 1990, following 1987, in 1989. Kim 00 has been punished for suspicion of cannabis smoking twice in 1987 and 1991. subsequently, Shin 00 also made a controversy in allegations of smoking marijuana in 1999. These were mainly recalled "I could not think that it was an illegal act, since I had a lot of ignorant curiosity, I looked at people who were smoking cannabis, and I was acting the same way without thinking." These are mainly suffered from depression, manic depressions after starting cannabis, regained healthy living after receiving professional psychiatric treatment. One of the reasons that these drugs continue to fail to stop drug use is the flashback. It is a phenomenon in which the hallucination state when drugs are taken in the past is displayed irregularly even after stopping taking narcotic drugs. It is a flashback which is one of the reasons why drug abuse can not be stopped.[6]

2.3 New drug case

2.3.1 methamphetamine

It is often called 'hiropon' in a representative psychotropic drug reflux (Article 2, No. 4 of the law concerning narcotics management). It is Japanese phonetic pronunciation of philopon. 2001 year another name 'Hwang 00 incident' was a significant shock. She was indicted on charges of using philopon with Mr. Kang 00, a sales manager in an entertainment shop. At that time, "Hwang 00 stated that she knew that she had taken for liquor, but I did not know it was a drug." [7]

2.3.2 Ecstasy

Ecstasy was a medicine unfamiliar to the public at the time of 2001. Actor Sung 00 from Miss Korea suspended performance acting in the entertainment industry after being sentenced to two years in prison for eight months in prison with suspicion of taking ecstasy in 2002 Actor Ju 00 was also indicted on charges of using psychotropic medication such as ecstasy in 2009. Ecstasy is cheap, but its efficacy is not the same as conventional drugs, and it was easily distributed to young people through clubs at the time. The image of Ecstasy as a 'love pill' is one of many lies that are spread about the drug. Ecstasy is emotionally damaging and users often suffer depression, confusion, severe anxiety, paranoia, psychotic behavior and other psychological problems.[8] In addition, it causes long-term damage to the brain area involved in thinking and memory. It is traded mainly in the form of white powder or capsule tablets.

2.3.3 Propofol

In 2012, Propofol madness blew up in the entertainment industry which has been quiet for a while, Propofol is a drug used as a sleeping and anesthetic. but it is classified as a drug because it causes hallucination when it is overused or overdosed. It will be up to them to decide if they agree with the Los Angeles County coroner's office, which labeled Jackson's death a homicide. According to the 2009 autopsy report (pdf), "the cause of death is acute propofol intoxication," which caused the singer to stop breathing.[9] Lee 00 and Park 00 were involved in the propofol cases, and the stars who were surveyed said they administered medicines for neurosis and healing. All were released on probation.

3. Healing process by fusion medicine

3.1 Cause of increase Entertainment Drug Accidents

Recently, several countries are advancing the legalization policy of marijuana. In particular, it is pointed out that cases in the United States are being made to increase domestic drugs. In the United States, 29 states can legally use medical cannabis. and in the eight provinces, cannabis for leisure is also permitted.

Canada has been legalizing medical marijuana since 2001. subsequently, it is scheduled to plan to legislate cannabis for refuge by July 2018. There is an opinion that the tendency to legalize like this slows down the caution against drugs. Drug sellers are easy to purchase cannabis legalized locally. Attempts to distribute a large amount of these marijuana in Korea and to make money are gradually increasing. As a result, there is a growing possibility of drug exposures and risks from entertainers as well as the general public. The trading practices are also gradually changing behaviors that had been done in limited spaces like past, such as nightclubs and clubs. Now It is not stuck in the current place. Such reality makes it difficult for the police to investigate. In order to block domestic drug distribution, diversification phenomena of investigation methods are required.[10]

3.2 Introduction of fusion medicine program

South Korea is also preparing for various convergence programs focusing on natural sciences such as engineering, medical care, and the environment. In the meantime, there has been an effort to research and seek the fusion of both the representative of East and West medicine for 27 years. That is the emergence of the

Fusion Medical Center.[11]

Western medicine has the strength of rapid treatment and detailed observation. However, It focuses on the present condition and symptoms of the disease. This can be seen as observing trees rather than forests. On the other hand, Oriental medicine has the strength of nurturing and preventing nourishment of the body. However, because the emphasis is placed on the inherent cause of the disease, the current treatment is also slow. For example, You can say that you are more focused on forest than tree. Here, there is alternative medicine as a third zone treatment. For example, include meditation, yoga, art therapy, and psychotherapy. Usually these treatments are said to be non-invasive natural therapy,[12] However, there is a vulnerability on the scientific evidence and regular screens.

The Korean type natural healing is aiming for more complete treatment by adding abundant natural environment in addition to the medical fusion of oriental medicine, western medicine, and alternative medicine, These courses of treatment have the strength to improve calm and natural immunity. Treatment through fusion medicine is expected to play its role as soft and natural immune therapy. It treats the background of cancer, minimizes side effects of treatment, enhances the natural healing power and immunity of the body. In the future, we will hurry the process of constructing a lot of natural environmental hospital systems and creating a naturally friendly treatment environment. Under the current law, drug crime is punished by the application of the Act, even for entertainers and non-entertainers. We need to understand why celebrities needed drugs. We need to worry about how to do it in order to avoid the need for drugs any longer. These problems need to tell the more important meaning that We have to solve together.

4. Measures to prevent drug addiction

4.1 Improve related laws and strengthen education

Even in patients who are currently in hospital drug addiction, when new medical treatment is done, they are reported to the relevant agency if they are to be newly treated. In this case, it is necessary to prepare related laws so that doctors mandate declaration regulations for addicts. After reporting, it is necessary to reduce the possibility of avoiding reporting by preparing a system that can be converted to treatment rather than punishment.[13] As a part of treatment and rehabilitation education, there is a request(Korean Drug Crime Society) to remove addiction such as narcotics and to consider recurrence prevention education method etc. Removed poisoning such as narcotics in Korea, developed mainly focusing on lifelong education technique ‘Immune therapy’ to prevent recurrence. It is a NK cell (NaturaI Killer, natural killer cell) that eats bad bacteria, MP cell (Macrophage cell), a serotonin teaching technique to stabilize the heart.[14]

4.2 Expansion of private treatment facilities

Following the revision of these related laws, it will be necessary to establish the department responsible for the country, enhance the capacity of natural healing. In particular, it is necessary to increase support. financial support for the expansion of drug addiction treatment institutions. In addition to government-designated narcotic addicts treatment agencies, it is urgent to expand private treatment facilities.
